**EDOM WATER SUPPLY CORPORATION
 NOTICE OF RATE INCREASE**

The Edom Water Supply Corporation (EWSC) Board of Directors held a public meeting on December 12, 2022 and voted to increase monthly rates on water service for all members. The Directors on the board consider these rate increases necessary to continue supporting current and upcoming projects that are critical for maintaining system infrastructure and also support the escalating costs of operations. These vital improvements further ensure the continuous strategic efforts that will secure the longevity of our water system.

EWSC Board of Directors have approved a \$3.00 increase to the base meter charge and a ¢.50 increase on each tiered rate for cost per thousand gallon usage. These rate adjustments will be reflected in your billing beginning February 2023.**

**** Due to the freeze in late December 2022, many customers suffered large usage amounts from water leaks. That water usage will be reflected in the February 2023 billing, causing those customers to pay for the larger usage at the increased rate.**

To offer effected customers some relief, the Edom WSC Board of Directors voted Monday, January 9, 2023, at the regular monthly board meeting, to postpone the rate adjustment one month.

The new rate adjustments will now be reflected in billing beginning March 2023.
